## COVID-19 WEEKLY REPORT

### DRIVING RANGES-NOT YET!



As the reopening phases of sectors are continually occurring, including Phase 1 and beyond, the Middleton Health Department has been very busy related to sector re-openings. The Health Department is not required to review reopening decisions or plans/protocols or engage in compliance of social and physical distancing, etc. within businesses/operations unless a complaint/inquiry is filed by the patron or employee.

All sectors at this point in time are required to self comply and follow the specific sector checklist that is outlined by the State of Massachusetts standards advisory board under the Baker-Polito Administration. There may be sectors that decide on their own to open against the Governor's phased reopening plan/order. Our goal is to always work with sectors and collaborate with them and encourage them to align properly.

This week two driving ranges opened against the Governor's phased plan/date and against the recommendation of the Middleton Health Department. Respectively, an inquiry was received and the Health Department had to initiate a response. When validated, an escalating procedure outlined the governor is put in place as follows: verbal redirection request, a written redirection request, fining of \$300 per visit, and then a cease and desist order.
