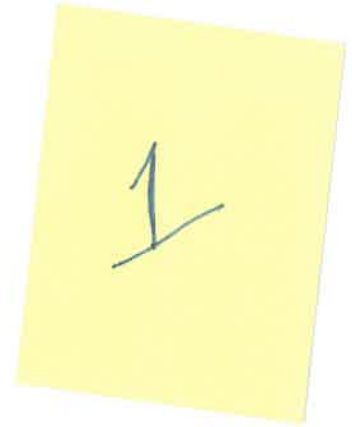

**7:08 PM** With a quorum present, Acting Chair Tim Houten called the meeting to order.

**7:04 PM ROUTINES**

- **Warrant Approval:** Town Administrator Andy Sheehan provided a brief review of Warrant #2223: Payroll: \$731,968; Bills Payable: \$3,037,706; noting that the Town Accountant had reviewed the warrant and requested the Board's approval. After a brief discussion, the Board took the following action:

On a **MOTION** made by **Prentakis**, second by **Garber**, the Select Board **VOTED** unanimously to approve the warrant as presented.

- **Minutes Approval:** The Board was provided with the minutes from the following meetings: March 22, 2022; April 5, 2022; April 19, 2022; and took the following action:

On a **MOTION** made by **Prentakis**, second by **Garber**, the Select Board **VOTED** unanimously to approve the minutes as presented.

- **Town Administrator's Report:** Town Administrator Andy Sheehan provided the Board with information and updates on the following:
  - **Town Meeting:** Sheehan reminded residents that Town Meeting will be held on May 10<sup>th</sup> at 7PM at the Howe Manning School gymnasium. Sheehan added that they are concerned about a quorum and encouraged everyone to attend. Sheehan also advised the Board that the warrant book has been mailed out to residents.
  - **Pre-Town Meeting:** Sheehan reported that the Pre-Town Meeting is scheduled for Thursday, May 5<sup>th</sup> at the Flint Library, at 6PM, adding that this is an in-person event.

- **Annual Election:** Sheehan announced that the Annual Town Election will take place on May 17<sup>th</sup>, from 7am-8pm at the Fuller Meadow School.
- **Earth Day:** Sheehan thanked everyone who attended the Earth Day event on Sunday, noting that it was a great success and a great day to be outside!
- **Winter Recovery Funds:** Sheehan reported that the town will be getting an additional \$162,000 in Winter Recovery Funds. He added that the money is like additional Chapter 90 funds. Sheehan advised the money should be coming in the next couple of months.
- **Memorial Day:** Sheehan announced that there will be a small Memorial Day ceremony on Monday, May 30<sup>th</sup>, at 11AM, at the library. Sheehan added that the flagpole there was taken down and it should be up this week.
- **Angelica's:** At Select Board member Garber's request, Sheehan provided a brief update on Angelica's property, noting that a meeting will be held in a couple of weeks to talk about development in general in the downtown areas, which may have some information on Angelica's. There have been private conversations with some people that are looking at it.
- **Traffic Study on Route 114:** At Select Board member Kassiotis' request, Sheehan provided a brief update on the traffic study on Route 114, noting that the state did a traffic audit at Sharpners Pond and 114. They will be doing a more comprehensive study along the entire Route 144 in Middleton. Sheehan's office has not heard back from them on that yet.

**7:14 PM Public Comment Period:** There were no public comments.

**7:15 PM Review the recommendations of Chief William Sampson to Appoint the Following to the Middleton Police Department with Terms Through June 30, 2025:**

- **Roby Deschenes as a Full Time Police Officer**
- **Isabella Palmeira as a Reserve Police Officer**
- **Isabella Palmeira as an Acting Full Time Officer**
- **Noorulain Tillu as a Reserve Police Officer**

Chief Sampson met with the Board to recommend that Roby Deschenes be appointed as a full-time police officer, Isabella Palmeira be appointed as a reserve police officer and as an acting full-time officer; and Noorulain Tillu be appointed as a reserve police officer. The Chief provided the Board with information on the candidates. After a brief discussion, the Board took the following action:

On a **MOTION** made by **Prentakis**, second by **Garber**, the Select Board **VOTED** unanimously to appoint Roby Deschenes as a full-time police officer, Isabella Palmeira as a reserve police officer and acting full-time officer; and Noorulain Tillu as a reserve police officer, for terms ending June 30, 2025. **Kassiotis abstained.**

Town Clerk Ilene Twiss was in attendance and held a brief swearing-in ceremony for the three new officers.

**7:23 PM Review and Vote on Middleton Police Policy and Procedure 4.30 "Organization" to Reflect the Captain and Detective Sergeant Positions:**

Chief Sampson provided the Board with a copy of Policy 4.30, Organization, reflecting the Captain and Detective Sergeant positions. After a brief discussion, the Board took the following action:

On a **MOTION** made by **Prentakis**, second by **Garber**, the Select Board **VOTED** unanimously to accept Middleton Police Policy 4.30. **Kassiotis abstained**.

**7:24 PM Review and Appoint a Veterans Services Officer with a Term Through June 30, 2025:**

Current Veterans Services Officer, Gary Bent, and candidate for Veterans Services Officer (VSO), Jerome Thomas, met with the Select Board for the appointment of the VSO for a term through June 30, 2025. Assistant Town Administrator Jackie Bresnahan provided information on the selection process used to fill the vacancy caused by the retirement of Gary Bent, after several years serving as the VSO. Jerome Thomas provided the Board with his experience in the Marine Corps, noting that he loves working with veterans and is looking forward to the position. After a brief discussion, the Board took the following action:

On a **MOTION** made by **Prentakis**, second by **Kassiotis**, the Select Board **VOTED** unanimously to appoint Jerome Thomas as the VSO through June 30, 2025.

After the vote, Town Clerk Ilene Twiss swore in the new Veterans Services Officer.

**7:28 PM Review and Discuss Annual Town Meeting:**

Town Administrator Andy Sheehan advised they are still concerned about having a quorum for Town Meeting and encouraged anyone listening to attend. Sheehan reported that there will be two consent agendas. One will be for Articles 19-24, the Masconomet amendment articles; and the other will encompass Articles 10-17, the CPA, revolving fund, two enterprise funds, MELD pilot payment, Chapter 90 authorization, and transfers to reserves. Articles 3, 4, and 5 do not need any action at this time, so they will be skipped over. There will also be two reports presented – one from the Town Building Committee and one from the Zoning Bylaw Review Committee.

Acting Chair Houten provided the Board with the names of those to be appointed to the Solid Waste Advisory Committee, noting that Jeffrey Garber, Richard Gregorio, and John Erickson were previously appointed. After a brief discussion, the Board took the following action:

On a **MOTION** made by **Garber**, second by **Kassiotis**, the Select Board **VOTED** unanimously to appoint Carolyn Damato MacPherson and Annette Wilton to the Solid Waste Advisory Committee for terms ending June 30, 2024.

**7:35 PM Review and Vote on Reid's Race, Sunday, July 17th, 2022:**

The Board was provided with information on Reid's Race to take place on Sunday, July 17<sup>th</sup>, noting that it's a county-wide bike race and they will come through Middleton on their way to Gloucester. Sheehan noted that they've done this for a few years and there has never been a problem. After a brief discussion, the Board took the following action:

On a **MOTION** made by **Prentakis**, second by **Kassiotis**, the Select Board **VOTED** unanimously to approve Reid's Race to be held on Sunday, July 17<sup>th</sup>, 2022.
